FY21 Class Registration Pilot Underway

This year, the NIH Training Center will pilot a new registration process. What does this mean for you? Instead of your FY21 NIHTC class registration being confirmed immediately and then awaiting two levels of approval in the Learning Management System (LMS), you will first be assigned to a waitlist.

- ALL registrations are sent to the waiting list
- 2 Student and Direct Supervisor receive pending approval notification
- 3 Direct Supervisor approves registration
- Final Approver approves registration and adds a valid Common Accounting Number (CAN)
- At the top of each hour, fully approved registrations move to the roster if a seat is available
- Student remains on the waiting list if NOT fully approved or if a seat is not available

Once approved by your manager and final approver with a valid CAN (Common Accounting Number), your registration will secure a spot on the class roster.

This process change will prevent a large number of CAN errors from being generated behind the scenes from incomplete or incorrectly filled registration approvals. However, we understand this system change may cause initial uncertainty about securing your seat in our FY21 classes. NIH Prepares for 2021 Management Seminar Series

It's nomination season for the 2021 Management Seminar Series (MSS). Nominations are due November 16, 2020.

The MSS engages both new and experienced NIH administrative and scientific staff to gain insight into leadership and management-related matters within the NIH community. The program introduces participants to dynamic NIH leaders and experienced practitioners in their fields, with presentations and interactive activities. This year's program features new opportunities for participants to develop relationships with colleagues across multiple ICs.

New Program Component

Two optional opportunities to forge deeper connections via additional breakout group sessions will be offered in April and June.

The MSS will begin virtually and be assessed later in the year for in-person sessions.
